Engineering Review of Federal Emergency Management Agency

(FEMA) Preliminary Flood Insurance Rate Maps

<u>RECOMMENDED ACTION:</u> Provide a recommendation to the City Council to consider appropriating \$20,000 from the General Fund Undesignated Reserve for professional engineering services to develop an additional technical response regarding the Federal Emergency Management Agency (FEMA) Preliminary Flood Insurance Rate Maps.

<u>FISCAL IMPACT</u>: Funding for these services was not included in the Adopted Budget for Fiscal Year 2018-2019. An appropriation of \$20,000 from the General Fund Undesignated Reserve to Account Number 100-3008-5100 (Public Works Professional Services) is needed to perform this work. The projected General Fund Undesignated Reserve at June 30, 2018 is \$32.4 million.

<u>DISCUSSION:</u> Council Policy #44 requires that all proposed appropriations over \$10,000 be reviewed and discussed by the Administration and Finance Subcommittee prior to being presented to the City Council. The proposed appropriation item will be discussed by the Council at its Regular meeting on June 25, 2018.

In September 2017, the City entered into a contract with Moffatt & Nichol to perform a review of the data, assumptions, and methods FEMA used to create the Preliminary Floodplain Maps. After this review, the consultant recommended performing a detailed review of areas near East Sea Level Drive, Malibu Road, and Pacific Coast Highway. Staff submitted an appeal to FEMA prior to the November 6, 2017 deadline and later provided FEMA with additional analysis. FEMA indicated that it will be providing the City with a detailed response to the City's appeal of the Preliminary Flood Insurance Maps. Staff recommends that \$20,000 be allocated to develop an additional technical response to FEMA's response to the City's appeal of the Preliminary Flood Insurance Maps.
